Greetings from the UP Center for Women's and Gender Studies! May this letter find you and your family well and in good health.

The UPCWGS, through the recently launched DaKILa (Data, Knowledge, and Information Launcher) online learning platform, is organizing a system level Gender Sensitivity Training from August 25 to 26, 2020 which will use blended digital learning approaches. The sessions with the resource speakers, as well as the breakout and workshop sessions, will be done through the Zoom app. Powerpoint presentations, additional references, activities, and evaluations will be made available through the DaKILa platform. The training primarily aims to promote and strengthen gender sensitivity among the staff of the various UP system offices. This is being done in compliance with the IRR of the Republic Act 9710, also known as the Magna Carta for Women, requiring employees of government offices to undergo gender sensitivity seminars and related training. Employees of the university are also required to attend an orientation on the UP Anti-Sexual Harassment Code of 2017.

In light of the COVID-19 pandemic, we understand that majority of the UP System employees are on a work from home set-up, and time management is indeed challenging. We divided the webinar into two consecutive days in order to enable our participants to continue to attend to their work duties and familial obligations.
