SUBJECT	:	Work Arrangements during the Enhanced Community Quarantine (ECQ) from 29 March 2021 to 04 April 2021

In accordance with the pronouncement of Malacanang regarding the implementation of the Enhanced Community Quarantine (ECQ) for the period of 29 March 2021 (Monday) to 04 April 2021) as a measure against the recent surge of the COVID-19 cases, please observe the following during this period:

- 1. Given the directive of a strict home quarantine in all households<sup>1</sup>, Units/Offices in the concerned CUs must implement alternative work arrangements (AWA), such as work from home (WFH). Heads of Offices/Units and immediate supervisors shall discuss with and assign tasks to their staff from 29 March 2021 to 31 March 2021 (Holy Wednesday, Half-day work only).
- In the exigency of service, Units/Offices may also implement skeleton workforce, but kept at a minimum. Travel passes are not required<sup>2</sup>, but exempted workers have to bring their UP ID for proper identification.

Units/Offices are also highly encouraged to make transportation arrangements for their skeleton workforce.

3. The UP-PGH Director and Chancellors of UPD, UPLB and UPOU may determine the work arrangements/ optimal operational capacity of Units/Offices specifically in charge of public health, safety and security, and other critical services in the campus, as necessary.

Per the Omnibus Guidelines on Community Quarantine<sup>3</sup>, full operational capacity is allowed in hospitals and health, emergency, and frontline services.
