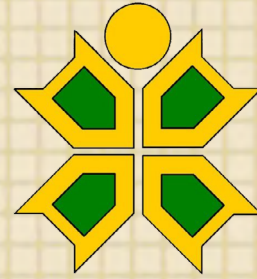


2022 Call for Nominations to the Deanship of the UP Diliman School of Urban and Regional Planning

Call for Nominations:

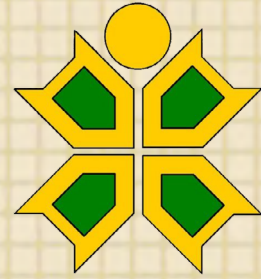
The search committee shall accept nominations **from 12 to 24 January 2022**. Please submit the following documents in electronic (PDF) copies with e-signatures affixed:

1. Nominator/s' signed nomination letter containing the justification for the nomination and the contact details of the (first) nominator
2. Nominee's summarized curriculum vitae (three pages at most)
3. Nominee's signed letter of acceptance of the nomination, stating willingness to serve as dean
4. Nominee's vision and plans for SURP in broad terms, including his/her flagship programs

2022 Call for Nominations to the Deanship of the UP Diliman School of Urban and Regional Planning

Who May Nominate:

SURP faculty, REPS, administrative personnel, students, and alumni; UP constituents; and other interested stakeholders

Who May be Nominated:

The nominee must possess the following minimum qualifications:

1. Filipino citizen
2. Commitment to academic freedom and the values and ideals of the University
3. Distinction or outstanding academic credentials in the nominee's field of expertise which should be along the lines of SURP's disciplines or fields
4. Leadership qualities and administrative capability
5. Must be willing to serve as dean
6. Must consider resource generation an important function of the position

The nominee need not be a faculty member at the time of nomination. Should s/he be appointed, s/he must have a faculty appointment.
