UP Diliman is endorsing the study of UP Manila entitled "COVID-19 vaccine hesitancy and vaccine intent in urban, rural, and remote settings" funded by the National Institute of Health and conducted in partnership with the Philippine Primary Care Studies. I. Title

COVID-19 vaccine hesitancy and vaccination intent in urban, rural, and remote settings

II. Objectives

The objectives of this study are to: 1) assess vaccine hesitancy towards the COVID-19 vaccine; and 2) identify factors associated with vaccination intent among unvaccinated adults in urban, rural, and remote settings in the Philippines.

III. Participants

This study will examine responses from all consenting unvaccinated adults in urban, rural, and remote settings in the Philippines. These sites are UP Diliman, the Municipality of Samal, and the Municipality of Bulusan accordingly. The proposed study targets a time-bound sample, with data collection set over 1 month for each study setting.

IV. Data Collection Methods

This study will use a self-administered survey, primarily through remote or online data gathering methods whenever possible. Face-to-face data collection will only be conducted in limited and highly restricted circumstances. While the proposed study does not pose any added risk of exposure to the participants, strict adherence to health and safety guidelines will be maintained among participants and research staff alike.

V. Significance of the Study

Attitudes and vaccination intent towards the available COVID-19 vaccines remain underexplored in low-middle income countries like the Philippines. Maximizing COVID-19 immunization through improved vaccine acceptance is especially critical in resource-limited settings. This study aims to address gaps in local literature by examining attitudes towards COVID-19 vaccines across urban, rural, and remote settings in the Philippines.
