WHO MAY BE NOMINATED:

THE NOMINEE MUST POSSESS THE FOLLOWING MINIMUM QUALIFICATIONS:

1. FILIPINO CITIZEN;
2. COMMITMENT TO ACADEMIC FREEDOM AND VALUES AND IDEALS OF THE
UNIVERSITY;
3. DISTINCTION OR OUTSTANDING ACADEMIC AND PROFESSIONAL
CREDENTIALS IN THE NOMINEE'S FIELD OF EXPERTISE WHICH SHOULD BE
ALONG THE LINES OF THE COLLEGE OF ARCHITECTURE'S DISCIPLINES OR
FIELDS;
4. LEADERSHIP QUALITIES AND ADMINISTRATIVE CAPABILITY;
5. MUST BE WILLING TO SERVE AS DEAN FOR A FULL TERM; AND
6. MUST CONSIDER RESOURCE GENERATION AN IMPORTANT FUNCTION OF
THE POSITION.

THE NOMINEE NEED NOT BE A FACULTY MEMBER AT THE TIME OF
NOMINATION. SHOULD THEY BE APPOINTED, THEY MUST HAVE A FACULTY
APPOINTMENT.
