Implementation of new traffic scheme along Quirino Street near

**UP Integrated School (UPIS)** 

To ease traffic congestion and ensure safety of students, the following scheme will be implemented effective November 11, 2025, Tuesday, along Quirino Street near Maria Regidor Street, adjacent to the UP Integrated School (UPIS):

Coverage and Purpose

This traffic adjustment covers Quirino Street (near Maria Regidor Street) within the UP Diliman campus. It aims to:

- a. Improve traffic circulation during peak hours;
- b. Provide a safe drop-off and parking zone for UPIS students, faculty, and employees; and
- c. Prevent congestion within the UPIS vicinity.

## Traffic and Access Arrangement

- a. One-way traffic flow
  - The portion of Quirino Street near Maria Regidor Street will operate as a one-way road, toward Quirino Portal.
  - The Quirino Portal will be open to allow exit toward Katipunan Avenue.
- b. Access restriction
  - The portion of Quirino Street near Maria Regidor Street will be exclusively for the use of UPIS.
  - Entry and exit will follow the designated one-way scheme.
- c. Partial road closure
  - The portion of Quirino Street from Africa Street to Maria Regidor Street will remain closed to through traffic, except during weekends and holidays.
- III. Designated Zones for Quirino Street near Maria Regidor Street
  - a. Pick-Up/ Drop-off Zone
    - Left side (toward Quirino Portal near UPIS HS Building) for UPIS student/ faculty/ employee pick-up/ drop-off only.
    - No parking will be allowed in this area.

b. Faculty and employee parking

• Right side (toward Quirino Portal) - reserved for UPIS faculty and employees with proper identification or parking permits.

These measures are implemented to support the safe and orderly movement of vehicles and pedestrians in the UPIS area.


